

የኮከ ኮላ አመልካች የግላዊነት ማስታወቂያ

የእርስዎ ግላዊነት ለኮከ ኮላ ኩባንያ፣ ለተባባሪዎቹ እና አጋር ድርጅቶቹ (በአጠቃላይ **ለኮከ ኮላ** ወይም **ለእኛ**) አስፈላጊ ነው። ኮከ ኮላ በእያንዳንዱ የእርስዎን የግል መረጃ የምንጠቀምበት ሀገር የግል መረጃን በኃላፊነት እና ተፈጻሚ በሚሆኑ ህጎች መሰረት ለመያዝ ቁርጠኛ ነው። ይህ የኮከ ኮላ አመልካች የግላዊነት ማስታወቂያ (**የግላዊነት ማስታወቂያ**) የኛን የቅጥር እድሎች ስታፈላልጉ ወይም እኛ ጋር ለስራ ስታመለክቱ ኮከ ኮላ ስለእርስዎ የሚሰበስበውን የግል መረጃ አይነት፣ ይህን የግል መረጃ እንዴት እንደሚጠቀም እና የግል መረጃዎ ላይ ያሉዎትን መብቶች ያብራራል።

በዚህ የግላዊነት ማስታወቂያ ውስጥ **የግል መረጃ**ን ስንጠቅስ አንድን ግለሰብ ለይቶ የሚያሳውቅ ወይም ለመለየት የሚያገለግል መረጃ ማለታችን ነው። ይህ ማለት የግል መረጃዎች ቀጥተኛ መለያዎችን (እንደ ስም) እና ቀጥተኛ ያልሆኑ መለያዎችን (እንደ የመሣሪያዎ መለያ ቁጥር) ያሉትን ያካትታሉ። ይህ ትርጓሜ በማናቸውም ተፈጻሚ በሚሆኑ አካባቢያዊ የመረጃ ግላዊነት ህጎች ሊሻሻል/ሊጨመርበት ይችላል።

እርስዎ ብለን ስንጠቅስ የኮከ ኮላ ሰራተኞች ያልሆኑ በኮከ ኮላ ውስጥ የሥራ ዕድል ለማግኘት የመጡ የውጭ አመልካቾች ማለታችን ነው። ብዥታን ለማስወገድ ይህ የግላዊነት ማስታወቂያ ከውስጥ የስራ ድርሻ ለሚፈልጉ የኮከ ኮላ ሰራተኞችን አይመለከትም። እንደዚህ ያሉ አመልካቾች በምትኩ ለኮከ ኮላ ሰራተኞች የግላዊነት ማስታወቂያ ተገዢ ይሆናሉ።

ኮከ ኮላ በዓለም ዙሪያ ከሚገኙ የተለያዩ አካላት የተዋቀረ ትልቅ ድርጅት ነው። በዚህ የግላዊነት ማስታወቂያ ሽፋን ላገኘው የግል መረጃዎ ሀላፊነት የሚወስደው አንዳንዴ **የመረጃ ተቆጣጣሪ** ወይም **ተቆጣጣሪ** - ተብሎ የሚጠራው የኮከ ኮላ አካል የት እንደሚኖሩ እና የሚፈልጉት የስራ እድል ላይ የተመሰረተ ነው። [የእያንዳንዱ ሀገር ተቆጣጣሪ አባሪ 1 ላይ ተዘርዝሯል።]

የኮከ ኮላ የግል መረጃ ክፍኔ ሁልጊዜ የሚመለከተውን ሕግ፣ የጽሑፍ ፖሊሲዎቻችንንና አሰራሮቻችንን እንዲሁም አስፈላጊ ሆኖ ሲገኝ ከሠራተኞች ተወካዮች ጋር የሚደረጉ የምክክር መስፈርቶችን ይከተላል። ይህ የግላዊነት ማስታወቂያ ከሚኖሩበት አካባቢያዊ ሕግ ጋር የሚጋጭ ከሆነ የአካባቢው ሕግ የበላይ ይሆናል። በተወሰኑ የአስተዳደር ክልሎች ውስጥ ስላሉ ሕጋዊ መብቶች እና መስፈርቶች ተጨማሪ መረጃ ለማግኘት እባክዎ ክፍል 8ን ይመልከቱ።

በዚህ የግላዊነት ማስታወቂያ ውስጥ ያለው ማንኛውም ነገር የኮከ ኮላን ፖሊሲዎች ወይም ህጎችን የመተላለፍ ወይም የተጠረጠሩ ጥፋቶች መፈጸምን ለማጣራት ወይም ህጋዊ ግዴታዎቹን ለመወጣት የግል መረጃን የመከወን አቅሙን የሚገድብ ተደርጎ መተርጎም የለበትም። ይህ የግላዊነት ማስታወቂያ በግልጽ ወይም በተዘዋዋሪ ለሥራ ወይም ለተወሰኑ ሁኔታ ማንኛውንም ጥቅም ወይም አያያዝ ቃልኪዳን ወይም ውል ለመፍጠር የታሰበ አይደለም።

ይህ የግላዊነት ማስታወቂያ ከካ ኮላ ከእርስዎ ወይም ስለእርስዎ በበይነ መረብ መስመር ላይም ሆነ ከመስመር ውጭ ከቅጥር እድሎች (“እድሎች”) ጋር በተያያዘ የሚሰበስበውን የግል መረጃ አያያዝን ይመለከታል።

ይህ የግላዊነት ማስታወቂያ የሚከተሉትን አይመለከትም ፡-

- ከ/ስለ ሰራተኞች የሚሰበስብ ግላዊ መረጃ። የከካ ኮላ የሰራተኞች ግላዊነት ማስታወቂያ ለእንደዚህ አይነቱ የግል መረጃ ተፈጻሚነት ይኖረዋል።

ከካ-ኮላ ከእርስዎ የቅጥር እድሎች ጋር በተያያዘ በተለያዩ ምክንያቶች ከእርስዎ ወይም ስለእርስዎ የግል መረጃ ይሰበስባል። ይህን መረጃ በቀጥታ ከእርስዎ እናገኘዋለን፤ እና አስፈላጊ ሆኖ ሲገኝ ከሌሎች ወገኖች (የእርስዎን የቅጥር/መልማይ ወኪል ጨምሮ) እንወስዳለን። ከካ ኮላ የሚሰበስበው የግል መረጃ ምን እና ለምን እንደሆነ ባለው እድል፣ ስልጣን እና በሚመለከተው ሕግ መሰረት ይለያያል።

በአጠቃላይ የማመልከቻ ሂደቱን ለመቆጣጠር እና/ወይም ለማንኛውም ሌላ ተዛማጅ እና ህጋዊ የስራ ምክንያት አስፈላጊ የሆነ መረጃ እንሰበስባለን። ከዚህ በታች የምንሰበስባቸውን ዋና ዋና የግላዊ መረጃ ዓይነቶች፣ ለምን እንደምሰበስብ እና ያንን መረጃ በምናይበት ጊዜ በምን አይነት ህጋዊ መሰረት እንደምንተማመን አስቀምጥናል። ይሁን እንጂ አንዳንድ የግል መረጃዎች ከአንድ በላይ ለሆኑ ምክንያቶች የሚሰበስቡ መሆናቸውን ልብ ይበሉ፤ ስለዚህ የተዘረዘሩት ምክንያቶች ለአንድ ዓይነት የግል መረጃ ብቻ የተወሰኑ አይደሉም። በተጨማሪም በዚህ ክፍል ውስጥ ስለ ህጋዊ መሰረት ያለው መረጃ ተፈጻሚነት የሚኖረው በሚመለከተው ህግ ህጋዊ መሰረት በሚያስፈልግበት ጊዜ ብቻ ነው። በክፍል 8 ላይ እንደተገለጸው ለተወሰኑ ሀገራት ሊሻሻል ይችላል እና በሚሰበስብበት ጊዜ ሌላ ህጋዊ መሰረት ሲገለጽ ተፈጻሚነት ላይኖረው ይችላል።

በአካል ቀርበው ቃለ መጠይቅ ለማድረግ ቀጠሮ ካስያዙ እባክዎን ኮከ ኮላ ተቋማትን በዝግ የቴሌቪዥን ካሜራዎች እና ለደህንነት ሲባል ሌላም የቪዲዮ ክትትልን እንደሚያደርግ ቀድመው ይወቁ። እነዚህ መሰሪያዎች በዋናነት ጥቅም ላይ የሚውሉት በመግቢያና መውጫ ቦታዎች፣ በአሳንሰሮች፣ በሎቢዎች፣ በውድ መሰሪያዎች ዙሪያ እንዲሁም በሌሎች ከፍተኛ የስርቆት ስጋት ባላቸው አካባቢዎች ወይም በጣም ሚስጥራዊነት ባላቸው ንብረቶች ላይ ነው። እንደ መጻፍ ሴት ወይም በቃለ መጠይቅ ክፍልዎ ያሉ የግል ቦታዎች ላይ የቪዲዮ ክትትልን አንጠቀምም። በሚመለከተው ህግ መሰረት አስፈላጊ በሚሆንበት ጊዜ የቪዲዮ ክትትል በሚደረግባቸው ቦታዎች ተዛማጅ ማስታወቂያዎችን እንለጥፋለን።

ኩኪዎች(Cookies)

ኮከ ኮላ የኮከ ኮላን የቅጥር ማመልከቻ ስርዓቶችን ሲጠቀሙ እርስዎን እና/ወይም መሰሪያዎን (ችዎን) ለመለየት ኩኪዎችን እና ሌሎች የመረጃ አሰባሰብ ቴክኖሎጂን ይጠቀማል። እነዚያን ስርዓቶች ሲጠቀሙ አመልካቹ አስፈላጊ የሆኑ ኩኪዎችን ለመጠቀም መስማማት አለበት።

ኩኪዎች ምንድን ናቸው?

ኩኪዎች ከበይን መረብ ማሰሻ መተግበሪያዎ ወይም ከኮምፒውተርዎ ሃርድ ድራይቭ የሚላኩ ወይም የሚደርሱባቸው ትናንሽ የጽሑፍ ፋይሎች ናቸው። አንድ ኩኪ በተለምዶ ኩኪው የተገኘበትን የምድብ ስም (የበይንመረብ አካባቢ)፣ የኩኪውን "የህይወት ዘመን" (ማለትም፣ ጊዜው መቼ እንደሚያበቃ) እና በዘፈቀደ የተፈጠረ ልዩ ቁጥር ወይም ተመሳሳይ መለያ ይይዛል። አንድ ኩኪ ስለ ኮምፒውተር ወይም ስለ መሰሪያዎ እንደ ቅንብሮች፣ የአሰሳ ታሪክ እና የኮከ ኮላን የቅጥር ማመልከቻ ስርዓቶችን በሚጠቀሙበት ጊዜ የተከናወኑ እንቅስቃሴዎች ያሉ መረጃዎች ሊይዝ ይችላል።

ኮከ ኮላ "ፕሮፊሎችን" (አንዳንድ ጊዜ የዌብ ቢኮኖች ተብለው ይጠራሉ) ይጠቀማል። ፕሮፊሎች ስለ ኢሜይል መክፈት እና ስለ ድሕረ-ገጽ አጠቃቀም መረጃዎችን በድሕረ-ገጾች እና በጊዜ ሂደት መሰብሰብ የሚችሉ ግልጽ ምስሎች ናቸው።

ኮከ ኮላ በኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች ውስጥ የሚያስቀምጥባቸው ኩኪዎች የመጀመሪያ ወገን ኩኪዎች ይባላሉ። በኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች ውስጥ በማንኛውም ሌላ አካል የሚቀመጡ ኩኪዎች የሶስተኛ ወገን

ኩኪዎች ይባላሉ። የሶስተኛ ወገን ኩኪዎች የሶስተኛ ወገን ገጽታዎችን ወይም ተግባራት በኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች ላይ ወይም በእነሱ በኩል እንዲሰሩ ያስችላሉ። የሶስተኛ ወገን ኩኪዎችን የሚያዘጋጁ ወገኖች የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶችን ሲጠቀሙ እንዲሁም የተወሰኑ ሌሎች ድሕረ-ገጾችን ለመጎብኘት ሲጠቀሙበት መሣሪያዎን መለየት ይችላሉ።

ኮከ ኮላ ኩኪዎችን እና ሌሎች የመከታተያ ቴክኖሎጂዎችን ለምን ይጠቀማል?

አንዳንድ ኩኪዎች የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች እንዲሠሩ ያስፈልጋሉ። ሌሎች ኩኪዎች በኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች ላይ ያለዎትን ተሞክሮ ለማሻሻል ያስችላሉ።

በኮከ ኮላ የቅጥር መተግበሪያ ስርዓቶች ላይ አገልግሎት ላይ የሚውሉ የኩኪ አይነቶች እና ጥቅም ላይ የሚውሉበት ምክንያት የሚከተለው ነው፡-

- **በጣም አስፈላጊ የሆኑ ኩኪዎች** የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች እንዲሰሩ ያስፈልጋሉ።

የመረጃ አሰባሰብ ቴክኖሎጂዎች ኮከ ኮላ ከአንድ ድሕረ-ገጽ ወይ ሌላ ድሕረ-ገጽ የሚደረገውን የትራፊክ አዝማሚያ እንዲከታተል እና የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶችን አፈፃፀም እንዲያሻሽል ያስችላል።

የእርስዎ የኩኪ ምርጫዎች

ኩኪዎችን ለመቀበል ወይም ላለመቀበል የመወሰን መብት አለዎት። ሁሉንም ኩኪዎች እንዲከለክል ወይም ኩኪ ሲቀመጥ እንዲያመለክት የበይነ መረብ አሳሽ መተግበሪያዎን ማዋቀር ይችላሉ። (አብዛኞቹ የበይነ መረብ አሳሽ መተግበሪያዎች ኩኪዎችን በራስ-ሰር ይቀበላሉ ነገር ግን ይህን እንዳይሰራ ማድረግ እንዲችሉ ለእርስዎ ይፈቅዳሉ። ኩኪዎችን እንዳይሠሩ ካደረጉ የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶች አንዳንድ ገጽታዎች በትክክል ላይሰሩ እንደሚችሉ ልብ ይበሉ።)

3. ኮከ ኮላ ራስ-ሰር የአሰራር ሂደቶችን ይጠቀማል?

በተወሰኑ ግዛቶች ውስጥ በህግ በተፈቀደለት ጊዜ ኮከ ኮላ የእጩዎችን የግል መረጃዎች በራስ-ሰር ለመከወን የራስ-ሰር ውሳኔ አሰጣጥ እና ተመሳሳይ መሣሪያዎችን ይጠቀማል (በአጠቃላይ “ራስ-ሰር የአሰራር ሂደት”)። አስፈላጊ ሆኖ ሲገኝ ራስ-ሰር ክወናዎችን በተመለከተ ማስታወቂያ እናቀርባለን እና/ወይም ፈቃድ እንጠይቃለን።

በተወሰኑ ግዛቶች(ሕጎች) በሚከተሉት ሁኔታዎች ውስጥ ራስ-ሰር የአሰራር ሂደቶችን ልንጠቀም እንችላለን፡-

- ለተወሰኑ የስራ ድርሻዎች የተለየ ችሎታ ያላቸውን ግለሰቦች በተሻለ ለመለየት ከ/ስለ አመልካቾች የተሰበሰቡ የተወሰኑ የግል መረጃዎችን እና ሙያ ነክ ዝርዝሮችን ለመተንተን
- ብዙሀኑን፣ ፍትሀዊነትን እና አካታችነትን ለማበረታታት
- የእጩ መለያዎችን እና ሌሎች የኮከ ኮላ የቅጥር ማመልከቻ ስርዓቶችን ለመቆጣጠር
- ህጋዊ ግዴታዎችን ለማክበር እና ህጋዊ መብቶችን ለመጠበቅ
- ያልተፈቀዱ ወይም ህገ-ወጥ እንቅስቃሴዎችን ለመከላከል፣ ለመመርመር እና/ወይም ለመለየት
